ANDHRA PRADESH	Sterling Palavelli Godaveri	<ul style="list-style-type: none"> <li>▪ No separate permission/e-pass required to enter Andhra Pradesh.</li> <li>▪ 14 days of quarantine is not required for people coming from other locations.</li> <li>▪ All the District Collectors are directed to randomly screen all the passengers coming by train from other states at the railway stations before they exit the station. Similar procedure will be followed for passengers coming from other states by bus at bus stations.</li> <li>▪ All the District Collectors of the districts having international airports and sea ports have been directed to screen all the international arrivals at the point of entry. Screening will do done with thermal scanners and by collecting the samples for COVID testing.</li> </ul>

If they are carrying a valid and verifiable Final Certificate Report of Covid-19 vaccination.</li> <li>2. If they are carrying a valid and verifiable RT-PCR Covid-19 Negative report taken within 72 hours of arrival time.</li> </ol> </li> <li>▪ RT-PCR or Rapid Antigen Covis-19 tests shall however be conducted on symptomatic incoming passengers by Air/Rail/Road to J&amp;K.</li> <li>▪ The maximum number of people permitted to attend any indoor/outdoor gathering shall be strictly restricted to 25. However, in Banquet Halls in Districts with positivity rate below 0.2 and weekly case load below 250, gathering shall be permitted up to 25% of the authorised capacity, preferably in open spaces, for vaccinated persons/ persons with verifiable RT-PCR or RAT not older than 72 hours.</li> <li>▪ Cinema halls and theatres, and multiplexes are also allowed to function with 25% capacity subject to condition that management will ensure strict compliance of Covid Appropriate Behaviour (CAB).</li> <li>▪ Swimming Pools are also allowed to function at 25% capacity subject to condition that management will ensure proper Covid Appropriate Behaviour (CAB).</li> <li>▪ Night curfew shall continue to remain in force in all districts from 9pm to 6am.</li> <li>▪ Inter State movement of passenger transport of SRTC/Stage Contract Private Passenger buses shall be permitted for fully vaccinated person or persons with verifiable RT-PCR not older than 72 hours or based on RAT on-spot with strict compliance with CAB.</li> <li>▪ Entry into parks shall be permitted to vaccinated persons only with due verification.</li> </ul>

KARNATAKA	Sterling Karwar	<ul style="list-style-type: none"> <li>▪ Negative RT-PCR certificate (not older than 72 hours )shall be compulsory produced by the passengers travelling on flight,bus train or personal transport entering to Karnataka from Maharashtra and Kerala.</li> <li>▪ Passenger travelling from Goa, Maharashtra and Kerala should carry RT PCR certificate compulsory.</li> <li>▪ Tourists booked for weekends with valid stay vouchers are permitted to travel in their cars/taxis and other means of transportations.</li> <li>▪ There are no restrictions for the in-house guests staying in Hotels/Resorts.</li> <li>▪ All facilities can be kept opened only for the in-house guests.</li> <li>▪ Guests can check-in and check-out of hotels with the proof of booking.</li> <li>▪ Safari in Forest areas and sanctuaries are permitted, following Covid appropriate behaviour.</li> <li>▪ Bars and restaurant will operate with 50 percent capacity in weekdays.</li> <li>▪ For Wedding: Maximum 200 pax for open places and 100 pax for closed places are allowed.</li> <li>▪ If international passenger tested positive at airport they will directed to Government hospital.</li> <li>▪ Weekend curfew from Friday 10 PM to Monday 5AM.</li> <li>▪ Swimming Pool and gym shall operate with 50% capacity.</li> <li>▪ Swimming Pool and gym are allowed for fully vaccinated along with negative RT PCR.</li> </ul>

The international passengers arriving from At Risk countries (declared by GOI from time to time) may be deplaned on priority and separate counters will be arranged by MIAL and Airport Authority for their checking. Such all passengers shall have to undergo mandatory 7 day institutional quarantine and RTPCR test to be carried out on days 2,4 and 7 for these passengers. If any of the test is found to be positive, then the passenger shall be shifted to a hospital. In case of all tests coming negative, the passenger will have to undergo a further 7 days of home quarantine.</li> <li>2. Passengers from any other countries except the At Risk countries will have to compulsorily undergo RTPCR test at the airport on arrival and on being found negative, will have to undergo 14 days of home quarantine. If found positive, they will be shifted to the hospital.</li> </ol>

In the case of passengers from other States, negative RTPCR test within 48 hours of arrival will be compulsory without exceptions.</li> </ol> <p><b><u>Railways</u></b></p> <ol style="list-style-type: none"> <li>1. All passengers travelling to Maharashtra by trains originating or having halt/stop at stations in the NCR Delhi, States of Rajasthan, Gujarat and Goa shall carry with them RT-PCR negative test report.</li> <li>2. The RT-PCR sample collection should have been done within 96 hours before the scheduled arrival in Maharashtra.</li> <li>3. Passengers not having the RT-PCR test negative report shall be screened for symptoms and body temperature at the alighting railway stations.</li> <li>4. The passengers without symptoms would be allowed.</li> <li>5. Passengers who display symptoms shall be segregated and made to undergo Antigen Test. If the Antigen test shows negative, the passengers will be allowed to go on to their destination.</li> <li>6. Passengers not testing/found COVID positive, shall be sent to COVID Care Centre (CCC) for further care. The cost of further care including CCC shall be borne by the passenger themselves.</li> <li>7. The concerned Municipal Commissioners/District Collectors will be the Nodal Officers and ensure the instructions are followed strictly.</li> </ol> <p><b><u>Road Travel</u></b></p> <ol style="list-style-type: none"> <li>1. The concerned District Collectors of land border districts shall make arrangements to ensure that the passengers coming from the NCR Delhi, States of Rajasthan, Gujarat and Goa shall be tested for symptoms including body temperature.</li> <li>2. The passengers without symptoms will be allowed entry. Passengers with symptoms shall have the option of turning back and go to their home to recuperate.</li> <li>3. Passengers who display symptoms shall be segregated and made to undergo Antigen Test. If the Antigen test shows negative, the passengers will be allowed to travel further into Maharashtra.</li> <li>4. Passengers not testing/found COVID positive shall be sent to COVID Care Centre (CCC) for further care. The cost of further care including CCC shall be borne by the passenger themselves.</li> </ol>

Accordingly, MoCA vide OM dated 07-08-2020 has allowed for onward air journey of International arriving passengers, when exemption from Institutional Quarantine is granted by the state authorities (of the entry point) on the basis of negative RT-PCR test report, for which test was conducted within 72 hours prior to undertaking the journey.</li> <li>▪ Movement of person on Vande Bharat and air transport bubble flights will continue to be regulated as per SOP issued.</li> </ul> <p><b><u>Domestic Travellers:</u></b></p> <ul style="list-style-type: none"> <li>▪ The Odisha government has made it mandatory for people to show their COVID-19 negative report or a complete vaccination certificate to enter the state.</li> <li>▪ To enter the state, people will now have to produce either a negative RT-PCR test report not older than 72 hours or a final vaccination certificate after two doses of vaccination.</li> <li>▪ The rule will be applied on all modes of travel, train, bus, aeroplane, waterways or private vehicles.</li> <li>▪ The new guidelines also mentions if a person comes without these required reports or certificates, he/she will have to undergo seven days of mandatory institutional or home quarantine.</li> </ul>

RAJASTHAN	Sterling Mount Abu Sterling Atharva - Jaipur Sterling Sariska	<ul style="list-style-type: none"> <li>▪ For people travelling into Rajasthan from outside India, RT-PCR tests are mandatory, and the individual will have to be in institutional or home quarantine for seven days, or until test reports come negative for the virus.</li> <li>▪ Domestic travellers arriving in Rajasthan will have to produce double vaccination certificates or an RT-PCR negative test reports not older than 72 hours.</li> <li>▪ A maximum of 100 people are permitted at marriage functions, but this cap will be at 50 for those in municipal corporation and municipality areas till January 30.</li> <li>▪ Cinema halls, multiplexes, amusement parks, banquet halls etc will have to operate with 50 per cent occupancy and close by 8 pm.</li> <li>▪ Shops, malls and other commercial establishments will be allowed to be open till 8 pm, while restaurants and clubs can operate till 10 pm with 50 per cent of seating capacity, as per the guidelines.</li> <li>▪ All religious places will remain open till 8 pm, but offerings like garlands, prasad, chadar and other things are banned.</li> <li>▪ The night curfew will continue to remain in force from 11 pm to 5 am daily.</li> <li>▪ All the passengers/guest has to carry double dose certificate or RTPCR test report (in case of not have the 2nd dose certification) to enter in Mount Abu. If failed they will be vaccinated at the toll gate in Mount Abu and compulsory quarantine till the report arrived.</li> <li>▪ A curfew is imposed from 11 pm on Saturdays till 5 am on Mondays.</li> </ul>
